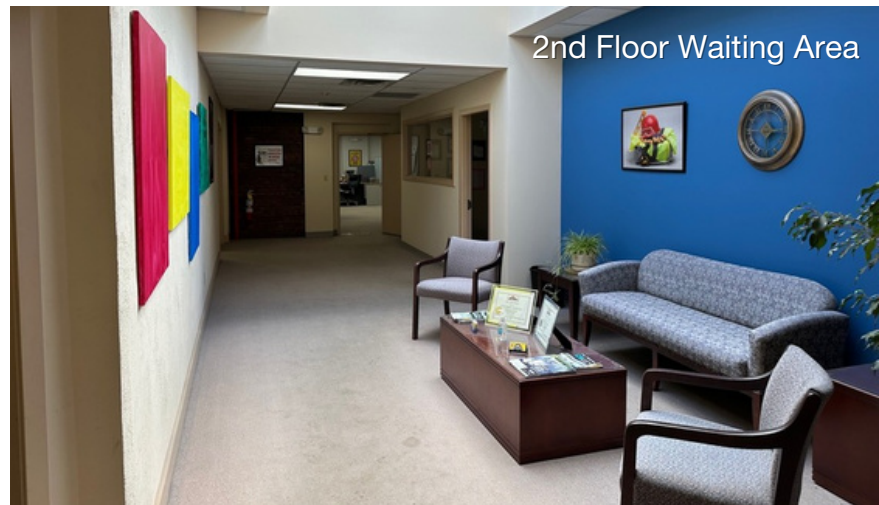
10-Car Parking Lot

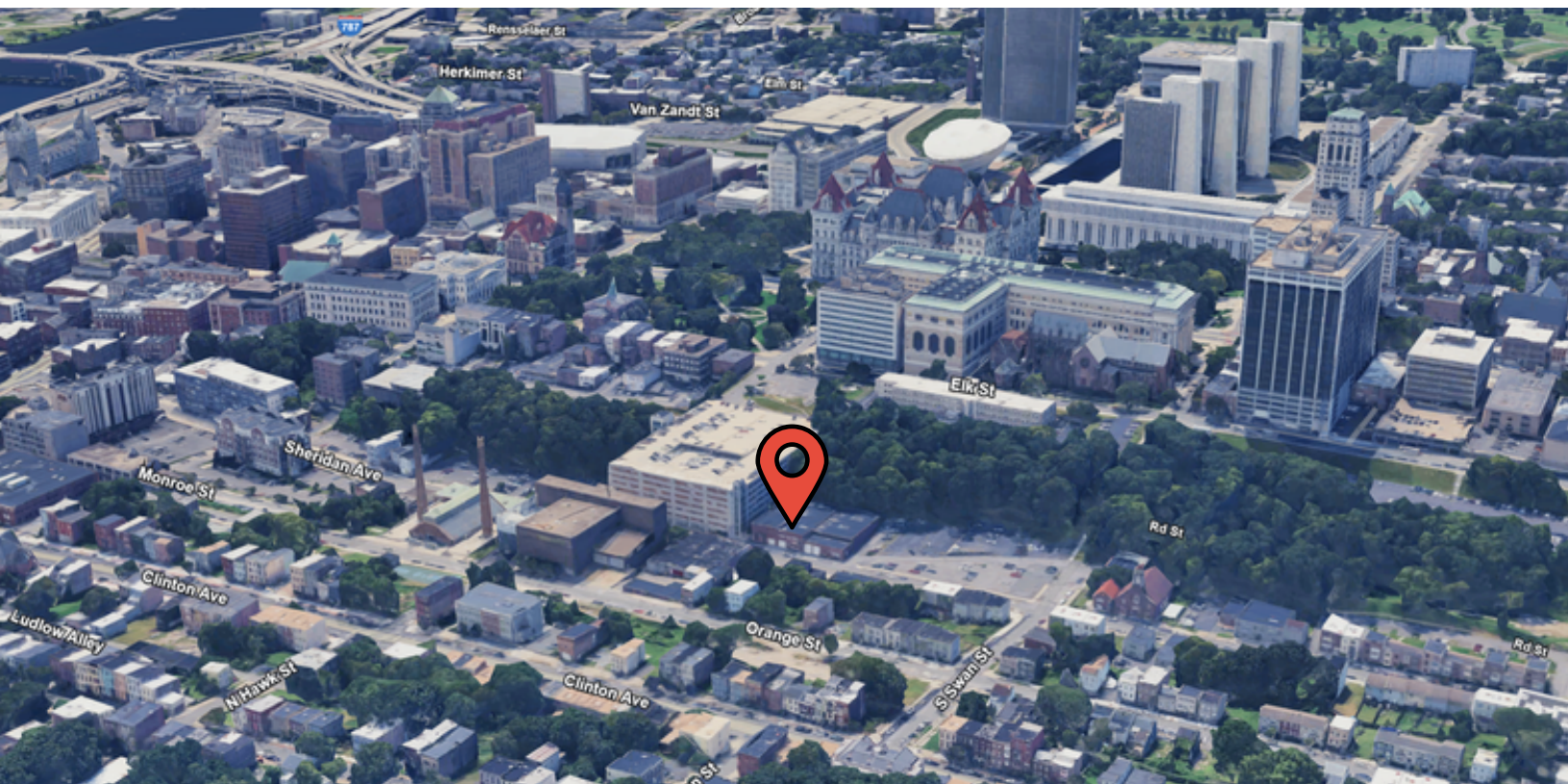

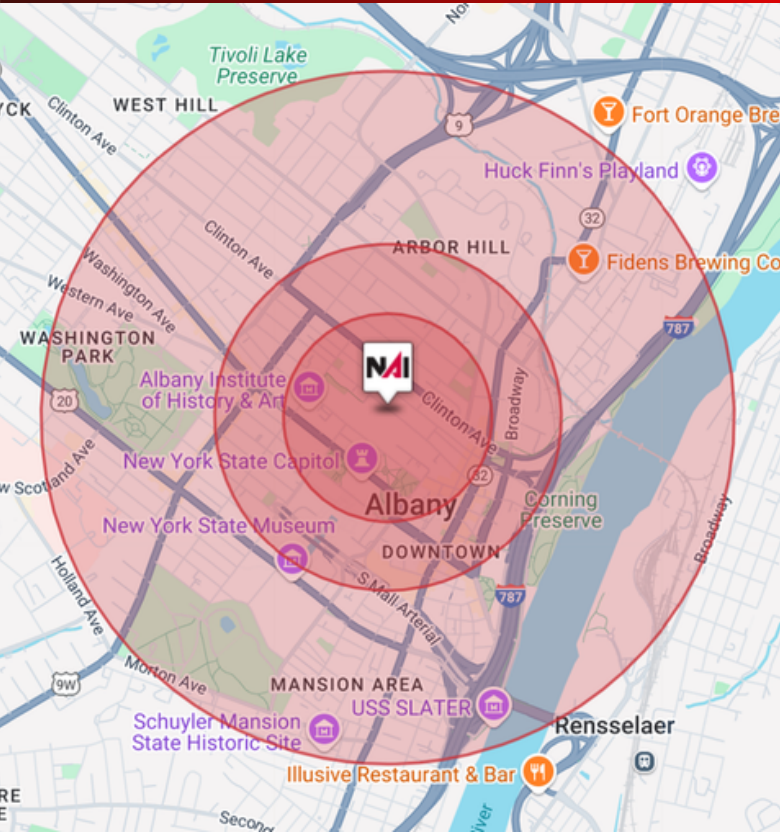

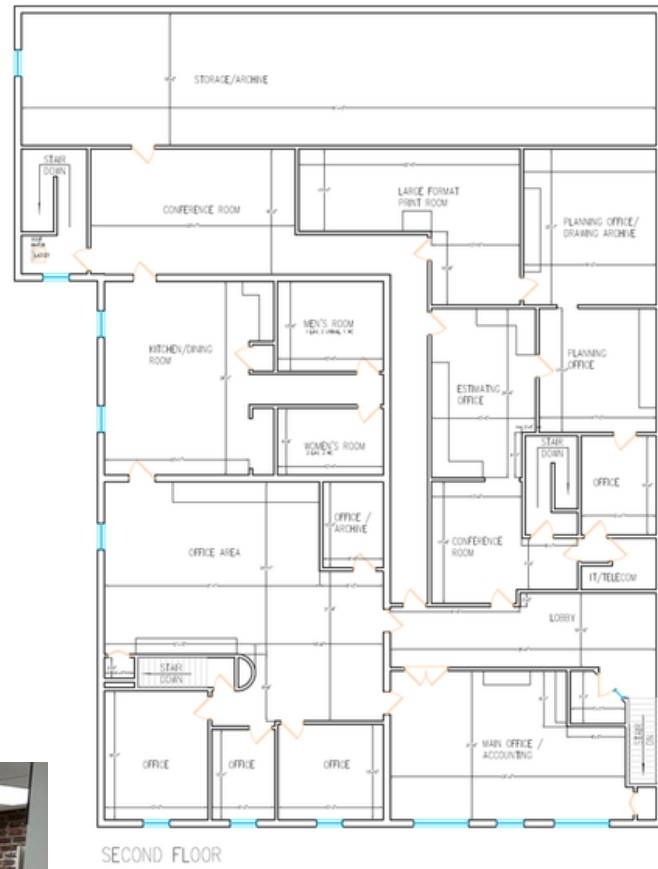
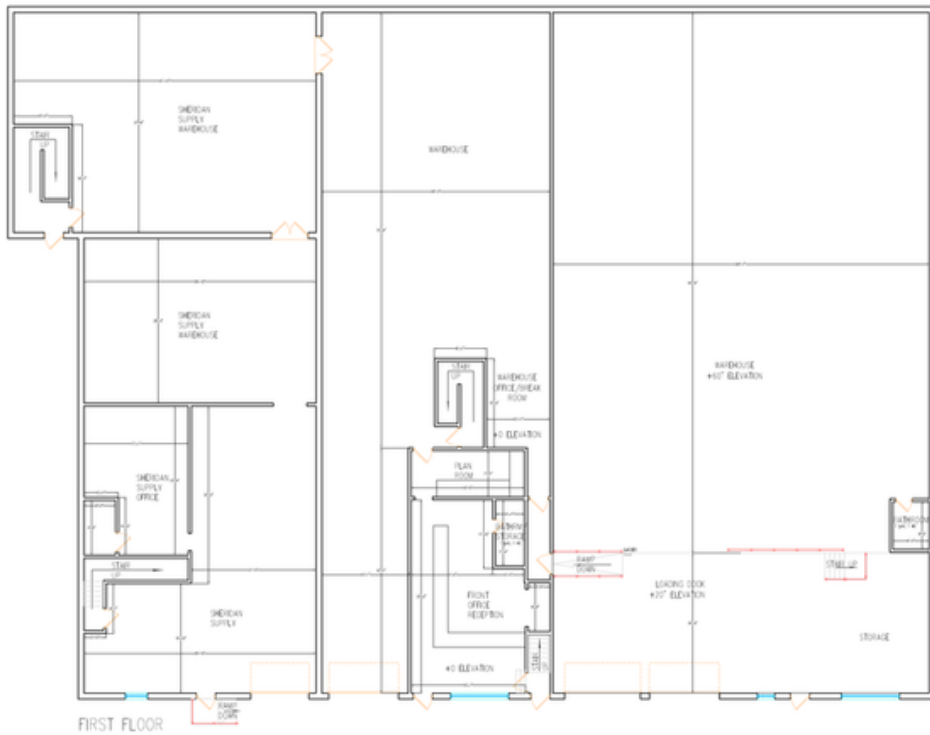
Parcel Tax Map
